2025-2026 Budget
Resolution

Motion:

It was moved by Mr. Guistwhite and seconded by Mr. Trone that the Board of School Directors adopts the attached resolution indicating the District will not raise property taxes by more than the 4.8% adjusted index for 2025-2026. By doing this, the Board of School Directors understands the following: (1) the District foregoes the preliminary budget process in January-February 2025 and is instead only subject to the traditional June budget timeline, (2) the District cannot seek referendum exceptions from PDE or the Court of Common Pleas to raise taxes beyond its index, and (3) the District cannot ask voters in the May primary election to authorize increasing any tax rates beyond 4.8%. Motion carried on a roll call vote 8-1, with Mrs. Thomas voting in the negative.

Dr. Argot shared proposed revisions to Board Policy 109: Resource Adoption.
