Larry Cox, Lewisberry, wants the project for athletics to move forward at Red Land High School.

Julie Estep, New Cumberland, defended “The Talk” on natural development, indicating that it is not pornography.

Sandra Gonzalez, York Haven, expressed support for the athletic project on the Red Land High School campus.

Danielle Gross, Etters, expressed concerns that “The Talk” was canceled and shared concern about the delay of TEAM. She also expressed concerns about the new public comment restrictions.

Kristi Harmon, Mechanicsburg, is concerned about missing community members from the Comprehensive Plan.

Bruce McLanahan, Camp Hill, presented a letter from Senator Mike Regan in support of a Red Land High School Sports Complex attached to the high school.

Stephen Perkins, Etters, expressed support for an outdoor sports complex and parent rights for sex education.

Matthew Plever, Etters, thanked teachers and administrators before sharing his support for Red Land High School’s football field project.

Dora Polk, New Cumberland, indicated she did not want to cancel Byrnes Health Education Center, but was focused on her children. She did express support for the Red Land High School Athletics project.

John Rados, Jr., New Cumberland, expressed support for the Red Land High School outdoor field project.

Casey Reed, New Cumberland, expressed concerns for Board Policy 908, the Comprehensive Plan, and Byrnes Health Education Center.

Mariana Reed, New Cumberland, explained why parents have the right to talk to Board members and questioned the integrity of the Superintendent.

Mike Reese, New Cumberland, expressed support for the Red Land High School Athletics Facility project.

Erick Rittle, Etters, wants there to be a vote in March for Red Land Club Sports and Performance Training.

Leroy Sheaffer, Lewisberry, shared his support for the Red Land High School Stadium project.

Mike Sweigart, New Cumberland, shared his history with the Red Land High School Football program and expressed his support for home field advantage at the Red Land High School.

Greg Troup, Dover, indicated Red Land High School deserves a home complex.

Garry Wintermyer, York Haven, expressed his support for a Red Land High School sports complex.

Kristi Alwine, Mechanicsburg, expressed concerns that an unsanctioned SEL program is being taught in one of her child's classes. These comments were shared with the Board in advance of the meeting.

Joei Askey, Lewisberry, expressed concerns about the breakdown in the relationship between The West Shore School District and Byrnes Health Education. These comments were shared with the Board in advance of the meeting.

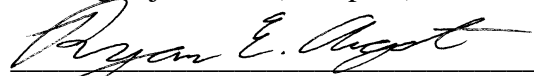
