Claudia Giardina, Camp Hill, expressed her support for the way the District has kept students learning and safe over the last two years. These comments were shared with the Board in advance.


John Hayden, New Cumberland, expressed his support for the way the Board has handled the safety of students and staff over the last two years. These comments were shared with the Board in advance.
