The West Shore School Board met in regular session at 6:33 p.m. with President Thomas presiding.

The opening ceremonies were led by Cedar Cliff High School JROTC comprised of Senior Austin Snavely, Junior Derek Cruz Andujar, Steward Dougherty and Freshman Aubrey Jones. A Crossroads Middle School Brass Ensemble performance of the National Anthem preceded the Pledge of Allegiance.

Mr. Gay shared information about the AP Art History Resource Adoption.

Opportunity for Students to Speak on General Items Rossmoyne Elementary School Fourth Grade Student Lilliya Fry asked the Board to allow all students to exist.

Cedar Cliff High School Senior Tristan Metherell expressed concern for the direction the Board is going and thoughts that the Board is turning its back on students.

Continued Opportunity for the Public to Speak on General Items from Meeting of April 11, 2024 Joei Askey, Lewisberry, expressed concerns about potential revisions to board policy. This comment was for the March 21 Board meeting, but was not included in the public comments at that time based on when the email came in and is being shared here for transparency purposes. It was shared with the Board members prior to the April 11 meeting.

Kirsten Cohick, Etters, highlighted "bad press" for the district, focusing on the behavior of Board members.

Donnamarie Dietz, Lewisberry, expressed frustration about the Board's private agenda.

Nicole Haas, Camp Hill, expressed concerns about the current state of the Board and the lack of transparency in decision making.

Jay Hess, Etters, expressed concerns about Board leadership and the qualifications of the potential new legal counsel.

Kari Hilt, York Haven, called on the Board President to resign.

Candice Kapranos, Mechanicsburg, encouraged the Board to move forward with Full Day kindergarten.

Victoria Madden, Lemoyne, advocated for a school board that works in good faith, elicits and considers input from the public and members of the community, while following well-established processes, laws, and regulations.

Sue Morrow, Etters, expressed dismay in the way the Board is running the district in a political/religious direction.

Carey Twigg, Lemoyne, expressed concerns about Board leadership.

The following comments were presented in person on April 18, based on "Blue Card" submission on April 11:

Sandra Gonzalez, York Haven, encouraged Board members to maintain their passion in spite of gas lighting.

Danielle Gross, shared that people who voted for the new Board members are telling her they regret their vote.

Kirsten Salvatore, Mechanicsburg, advocated for the Board members to get back to working as a collective group.

Opportunity for the Public to Speak on General Items

Joei Askey, Lewisberry, shared some literature resources related to LGBTQIA students and provided thanks for many of the Board for supporting all students. These comments were shared with the Board in advance of the meeting.

Doug and Mandy Brown, Mechanicsburg, advocated for the RFP process and expressed concerns about potential violations of the Sunshine Act. These comments were shared with the Board in advance of the meeting.

Lisa Budwig, Lemoyne, expressed multiple concerns over moving forward with the new solicitor. These comments were shared with the Board in advance of the meeting.

Deb Gray, Camp Hill, encouraged the Board to focus on making our schools better for students and asked some questions about how the Board will move forward. These comments were shared with the Board in advance of the meeting.

Allison Hollen, Etters, expressed multiple concerns and raised questions over moving forward with the new solicitor. These comments were shared with the Board in advance of the meeting.

Candice Kapranos, Mechanicsburg, encouraged the Board to move forward with Full Day kindergarten. These comments were shared with the Board in advance of the meeting.

Heather Keller, New Cumberland, expressed concerns about the Board's decision making process and encouraged the Board to focus on children and their needs. These comments were shared with the Board in advance of the meeting.

Ashley McHale, New Cumberland, expressed concern about the

impropriety of hiring a solicitor without an RFP. These comments were shared with the Board in advance of the meeting.

Tom Palisin, New Cumberland, expressed concerns about violations of the Sunshine Act and encouraged the district to move forward with the RFP process. These comments were shared with the Board in advance of the meeting.

Kelly Pennypacker, Camp Hill, expressed support for the Board and apologized for how people are behaving. These comments were shared with the Board in advance of the meeting.

Greg Roof, Lewisberry, found it appalling the District circumvented the RFP process. These comments were shared with the Board in advance of the meeting.

Nancy Sheets, Lemoyne, expressed concerns with Board leadership. These comments were shared with the Board in advance of the meeting.

Karen Taylor, New Cumberland, expressed concerns about the new solicitor and how that relationship will work. These comments were shared with the Board in advance of the meeting.

Jane Vivier, Etters, expressed multiple concerns over moving forward with the new solicitor along with support for school employees. These comments were shared with the Board in advance of the meeting.

Nicki Wilson, New Cumberland, expressed concerns related to decisions made at last week's Board meeting. These comments were shared with the Board in advance of the meeting.

Donielle Cribben, Mechanicsburg, shared her thoughts on the disappointing response to speakers.

Julie Estep, New Cumberland, advocated for transparency and fiscal responsibility.

Sandra Gonzalez, York Haven, indicated people support the direction of the Board.

Bill Gramlich, Camp Hill, expressed concerns for how the new Board is being threatened.

Danielle Gross, Etters, shared appreciation for everyone's flexibility when students and staff were running late due to excessive traffic caused by a highway fatality and expressed concerns about the potential hiring of a RCAP lobbyist.

Jeff Harmon, Camp Hill, expressed concerns about the way Board leadership has been moving focusing on the change in legal counsel and asked leadership to resign.

Jay Hess, Etters, talked about intent versus impact highlighting his concerns with the impact of recent decisions.

Celeste Jack, Camp Hill, prayed for everyone in the room.

Dora Polk, New Cumberland, welcomed the new solicitor.

Casey Reed, New Cumberland, shared his concerns for inaccurate media coverage of changing legal counsel.

Kirsten Salvatore, Mechanicsburg, thanked staff for their support of Special Olympics and advocated for enhanced support/training for staff.

Janel Trowbridge, Dover, expressed concerns about loss of the fourth grade instrumental program and advocated for full day kindergarten.
