Food Services  
Management Company  
Renewal, Meal Price  
Determination, and  
Budget Adoption  
2021-2022

Motion: It was moved by Mr. Guistwhite and seconded by Mrs. Crocenzi that the Board of School Directors approves the Food Service Management Agreement between the West Shore School District and Sodexo Quality of Life Services for the period July 1, 2021, to June 30, 2022, approves the school meal prices for 2021-2022 as presented, approves the 2021-2022 Food Services budget as attached, and authorizes Administration to pursue federal waivers enabling the District to feed students for free. Motion carried on a roll call vote 8-0. Mr. Guistwhite and Mrs. Crocenzi commended the work of the Food Service Department, both the improvement over the last few years and the work of feeding children during the pandemic. Dr. Argot shared with the Board that Friday would be National Lunch Hero Day.

#### Information Items

Dr. Stoltz previewed the May 13, 2021, agenda.

Mark Binkley, Jr., Fidevia Construction Management and Consulting, provided an update on the work being done at Rossmoyne Elementary School.

Mrs. Stuck provided reports on the 2020-2021 Investment Update, Assessed Value Spreadsheet, Budget Status Reports, Capital Reserves Summary, and Rossmoyne Project.

Mrs. Stuck and Dr. Stoltz facilitated a conversation on the 2021-2022 General Fund Budget and announced the plan to have the Board vote on the proposed preliminary final budget next week. Changing the date of this vote will in turn cause the vote on the final budget to be delayed until June 17.

#### Recognition of Public – General Items


Ms. Allison Shipp, Camp Hill, expressed concern about Critical Race Theory (CRT) in general and had some concerns about the recent Board presentation on Diversity, Equity, and Inclusion and how that might be connected to (CRT). Dr. Stoltz explained that West Shore is not teaching CRT. He also shared that the District is dedicated to ensuring all students have equal access to opportunities. Diversity, Equity, and Inclusion work will help the District remove any barriers that may exist within the District. An example of removing a barrier is the District's intent to provide student transportation for this summer's instructional programs to all students.

Mrs. Kristen Salvatore submitted comments and a question about the West Shore School District Special Education spring athletic completion. Dr. Stoltz indicated families would be able to attend this special day and also clarified prior comments about the last day of school moving to June 3, acknowledging he unintentionally excluded special education low incident students from his prior comments about a planned calendar revision slated for the May 13 Board meeting.

There being no further business, President Kambic declared the meeting adjourned. (9:39 p.m.)
