Information Items Dr. Stoltz previewed the June 17, 2021, agenda and provided an update on the Health and Safety Plan.


Mrs. Stuck provided reports on the 2020-2021 Investment Update, Budget Status Reports, Capital Reserves Summary, and Rossmoyne Project.
