Bill Gramlich, Camp Hill, highlighted the Flight 93 Memorial, teach kids not to be selfish, advocated against teaching gender issues, and expressed support for Board leadership.

Dora Polk, New Cumberland, expressed her continuing concerns with computer technology and commended the recent fifth grade development presentation by Byrnes Health Education Center.

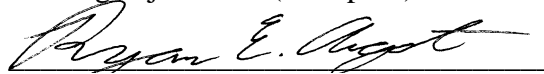
Mariana Reed, New Cumberland, submitted a petition about putting Dr. Stoltz on probation.
