		Dr. Stoltz facilitated follow-up conversation related to school safety with the Board. Direction was given to look at taking the steps necessary to secure vendor contracted security guards for the middle schools and school resource officers for the high schools. Mr. Guistwhite, Mr. C. Kambic, Mrs. Moyer, and Mrs. Tierney expressed interest in being part of the RFP team.
