Introduction

The opening of the Intermediate Schools, along with the closure of Fairview Elementary will significantly affect the elementary attendance areas. All of the elementary schools and middle schools will have boundaries that align with one of the two high schools when the updated boundaries are put in place. In addition to the closure of Fairview, minimally the attendance areas for Hillside, Fishing Creek, Newberry and Rossmoyne will be changed.

The boundary changes that come with the feeder school concept, which was adopted during the feasibility study, will affect how students matriculate. This document makes an assumption that following the construction of Old Trail Intermediate and Fairview Intermediate, the District moves immediately into detailed planning, bidding, and construction of the renovations and additions at Allen Middle School. In that assumption, planning for the renovations would take place during the 2024-2025 school year, with bidding and construction occurring during the 2025-2026 school year, and project completion during the 2026-2027 school year. This updated document includes enrollment projections for planned residential development.

Attendance Areas and Student Progression

The District has historically thought of, and administered, student attendance boundaries by level, and largely independent of one another. Meaning, we have a set of elementary attendance boundaries, a separate set of middle school attendance boundaries, and yet another set of high school attendance boundaries. As part of the feasibility study and in considering how these projects affect students and families, this document will focus on attendance areas. Attendance areas can be thought of as the intersection or layering of all three levels of attendance boundaries on top of one another.

Our goal based on feedback from the feasibility study has always been to unify the attendance boundaries so groups of students are not separated from their friends and peers as they move through the school system. There will be some necessary disruptions and transitions as we work through that process. It is important we keep this end goal in mind.

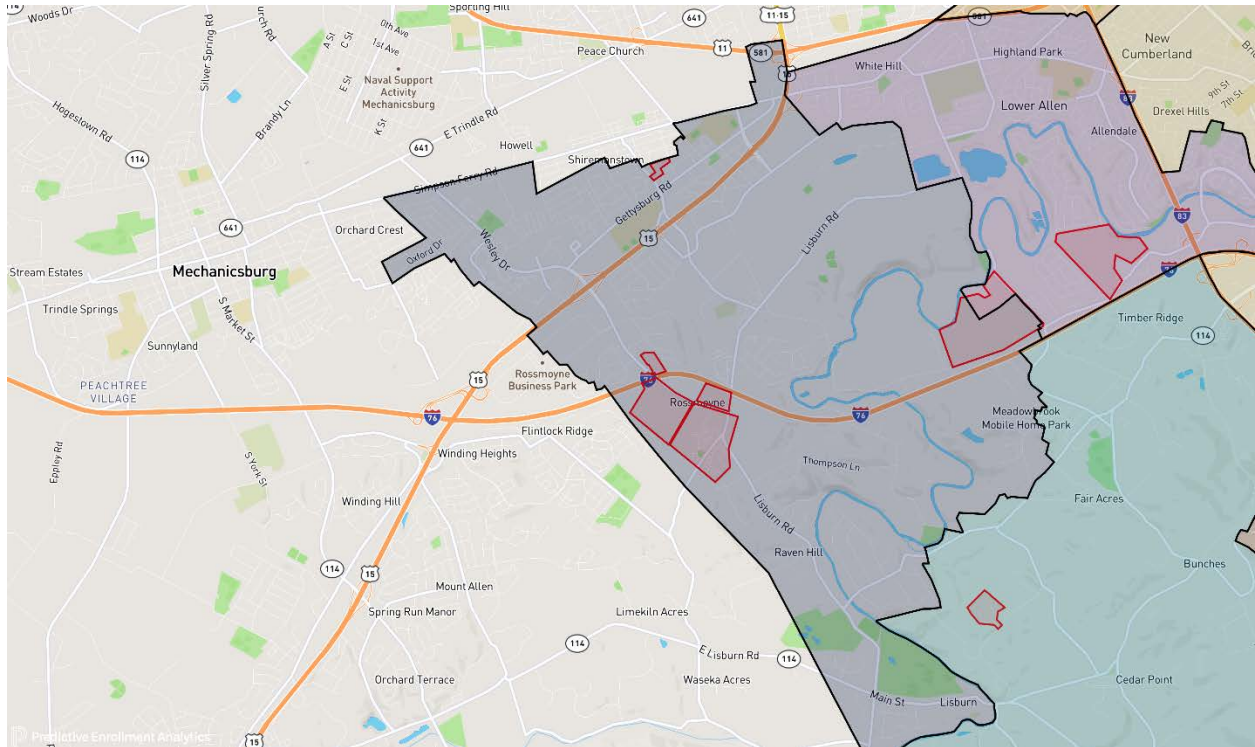
For each attendance area, a student progression grid has been provided. This shows how we envision each particular group of students moving through the buildings during the construction projects. The Rossmoyne/Allen/Cedar Cliff area is an example below.

To follow the progression for a grade level of student, find the grade level in the left-hand column called **Current Grade**. Then, follow the row across the table to the right. The first column shows what building that group of students are assigned to. For example, the Fourth grade students in the Rossmoyne/Allen/Cedar Cliff area are assigned to Rossmoyne in the 22-23 (current) school year. Next year, 23-24, those students would be assigned to Rossmoyne (as 5th graders). The following year, 24-25 that same group of students would be in 6th grade. However, the new Intermediate Schools would be open and that group of students would attend Fairview Intermediate as 6th graders. You can continue to follow any cohort of students all of the way through the grid to the 27-28 school year.

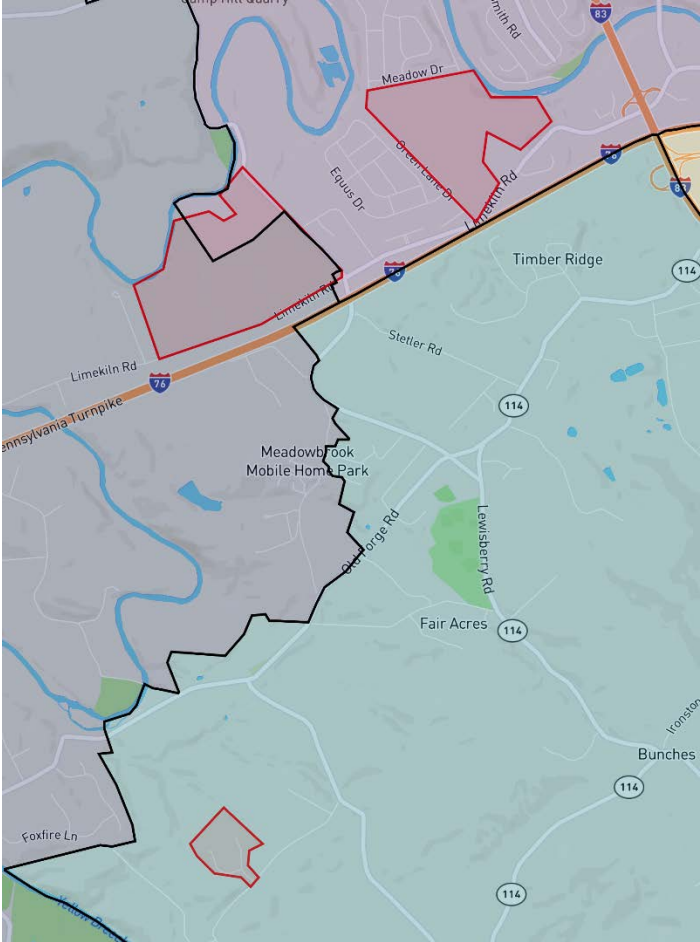
Residential Development Research

The school district continues to experience growth particularly in the Rossmoyne attendance area. The graphic below shows the planned developments outlined in red.



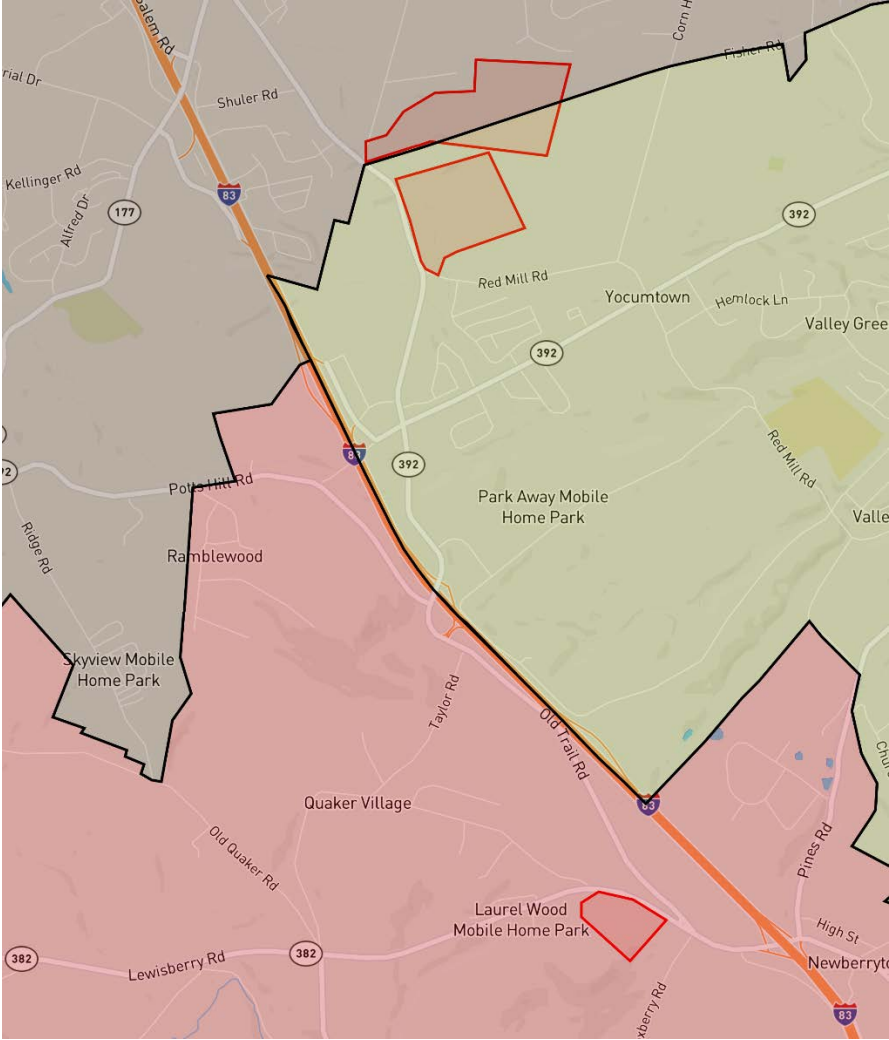
- Combined, the Arcona neighborhoods are projected to produce 110 single family detached units and 44 single family attached units.
- Birch Grove will produce 18 single family attached units.
- Lark Meadows will produce 13 single family detached units
- Sienna, which is mostly in the Rossmoyne attendance area, will produce 500 single family detached units and 150 single family attached units.

The graphic below shows the planned developments in the Highland and Fairview attendance areas.



- A portion of the Sienna neighborhood is in the Highland attendance area
- Green Lane Meadows, also in the Highland attendance area, will produce 208 single family detached units
- Oak Hill, located in the Fairview attendance area, will produce 13 single family detached units

The graphic below shows the planned developments in the Fishing Creek, Red Mill, and Newberry attendance areas.



- Southern Crossings, in the Fishing Creek attendance area, will produce 29 single family attached units and 70 single family detached units.
- Red Mill Crossing, in the Red Mill attendance area, will produce 450 multi-family units.
- Old Mill Road, in the Newberry attendance area, will produce 450 multi-family units.

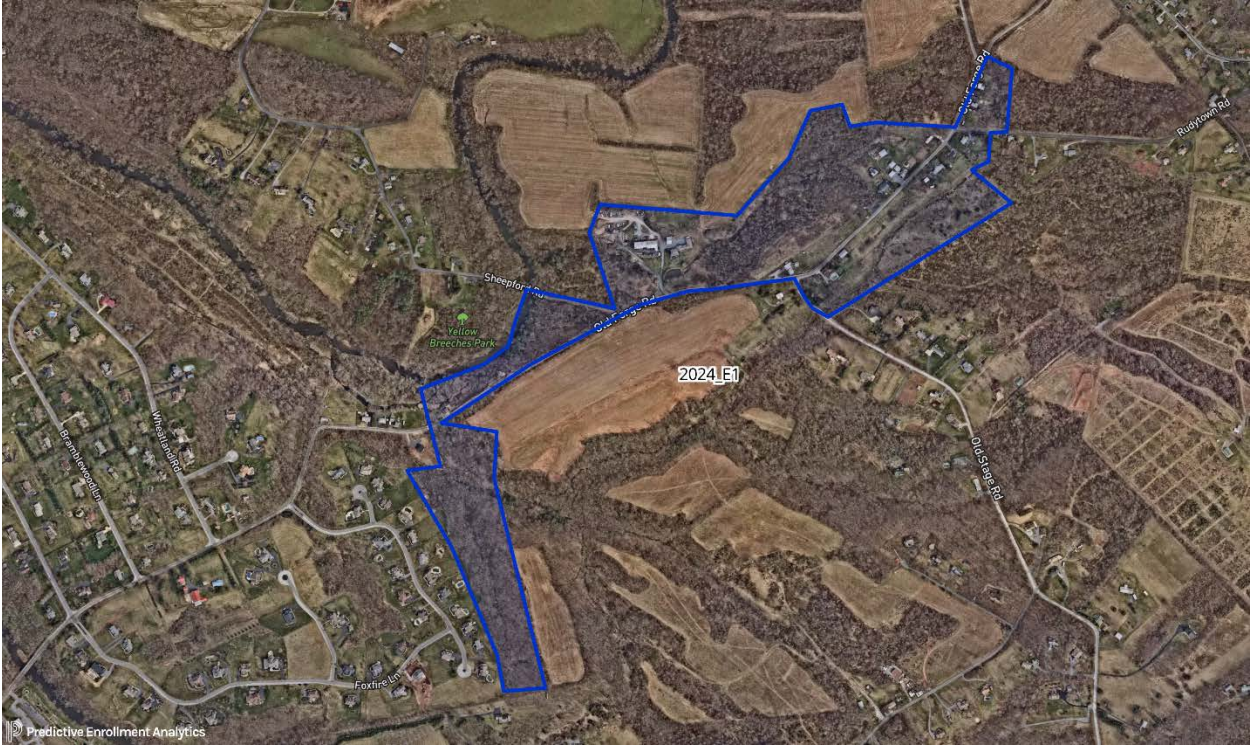
Enrollment Projections – Current Configuration

The table below factors in the enrollment projections including the planned residential development using our current building configuration. This provides a reminder of why the school district took on the Feasibility Study and initiated major construction projects. There are some buildings, like Fairview and Newberry, which do not operate efficiently because of their size and enrollment. Other schools struggle to find space for programs.

Introducing the Intermediate Schools will relocate fifth and sixth grade students, providing relief and space. In addition to the grade level realignment, multiple attendance areas need to be altered to accommodate the Fairview students. In that process there are other attendance changes that are recommended to rebalance student populations and account for the incoming new students generated by additional residential development.

Enrollment Projections – With All Proposed Changes

The table below factors in the enrollment projections including the planned residential development and incorporating all of the proposed changes for 2024-2025. The projection is showing the modeled enrollment for 2025. It is worth noting, the largest neighborhoods, Sienna and Green Lane Meadows, continue to generate students beyond 2025 as the construction is phased in. Highland would continue to experience growth from the residential development, and it is extremely likely we will need to implement the deferred changes at some point in the future to have the capacity for new students.

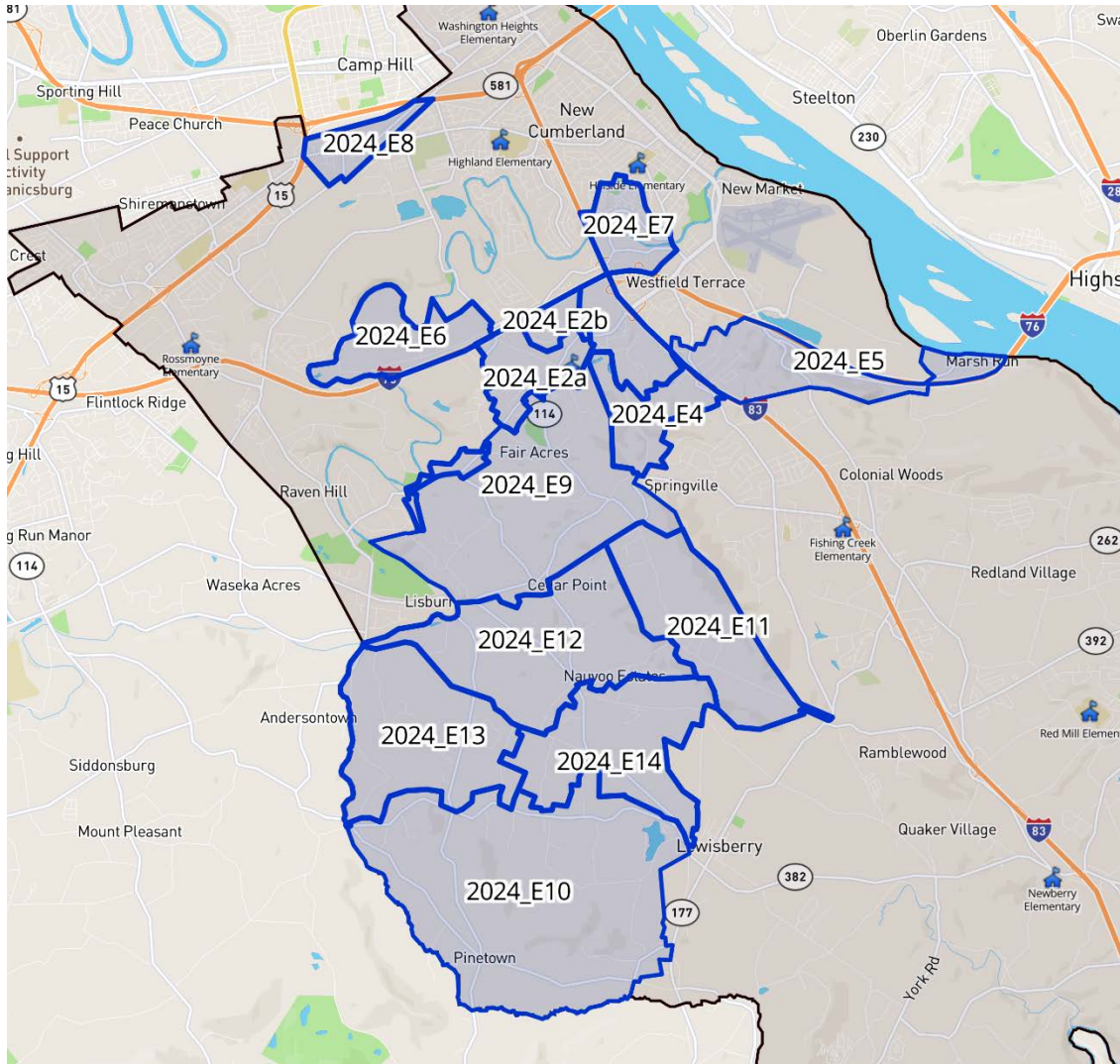

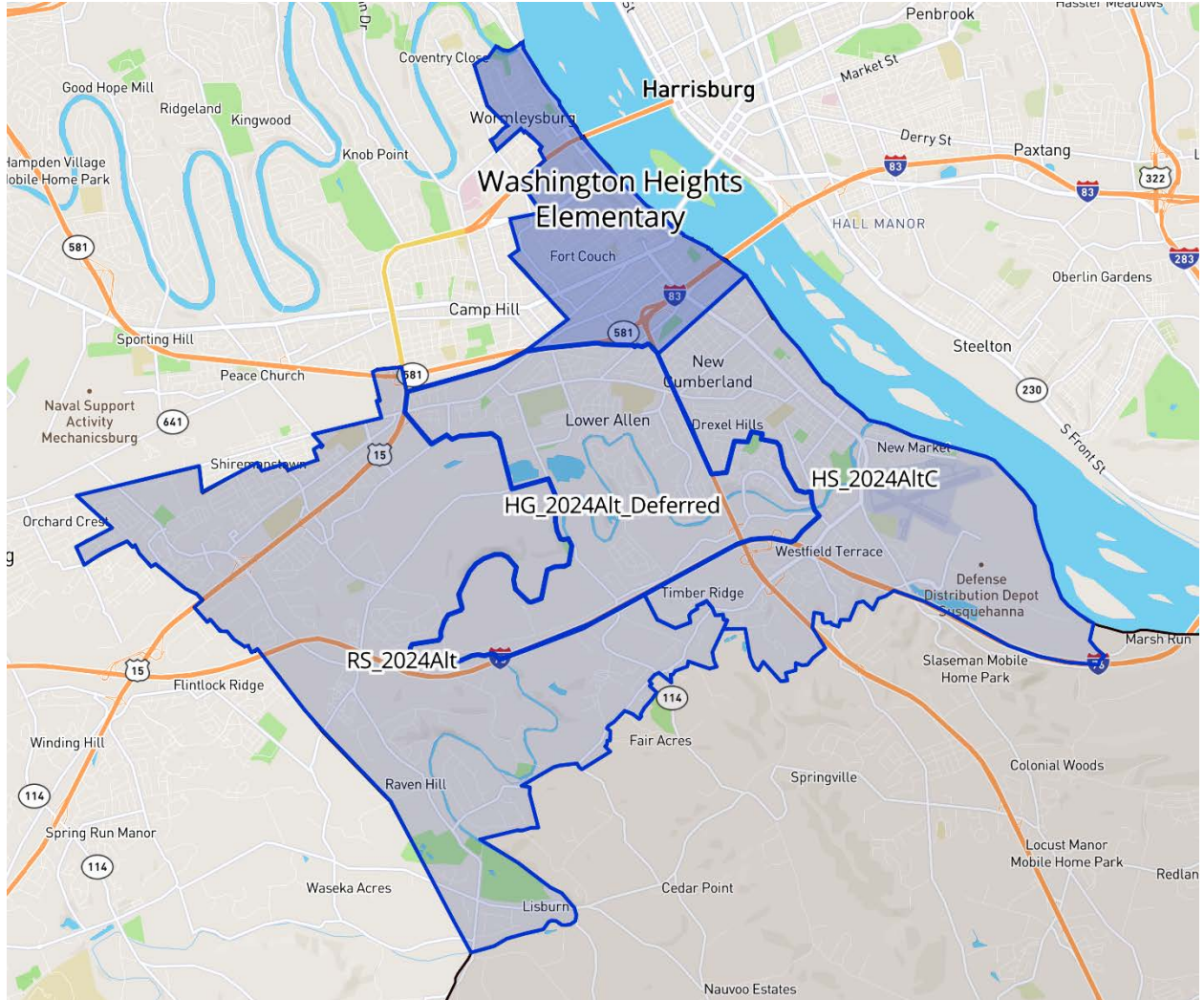

All Proposed Elementary Attendance Area Changes

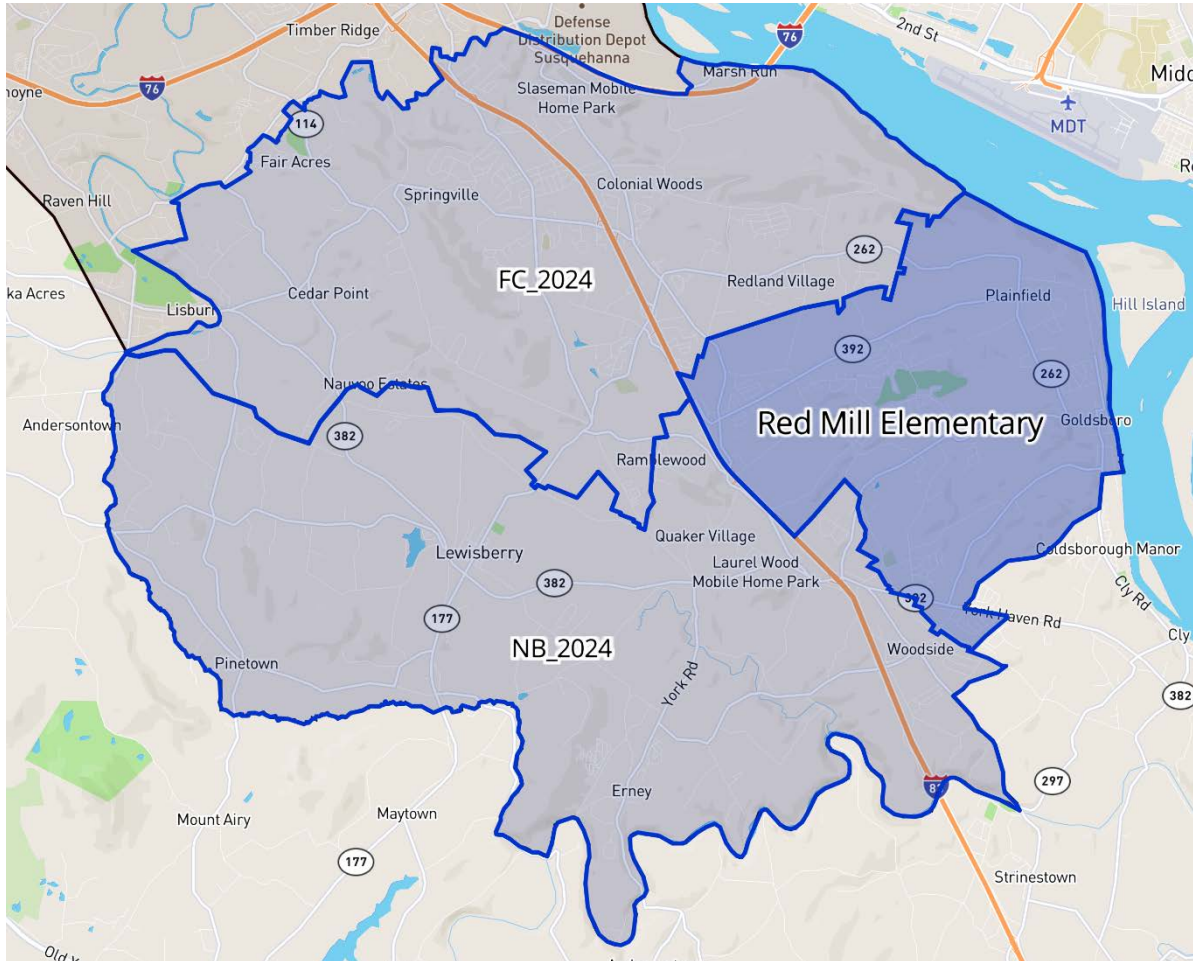

Updated Map: Red Land Elementary School Attendance Areas



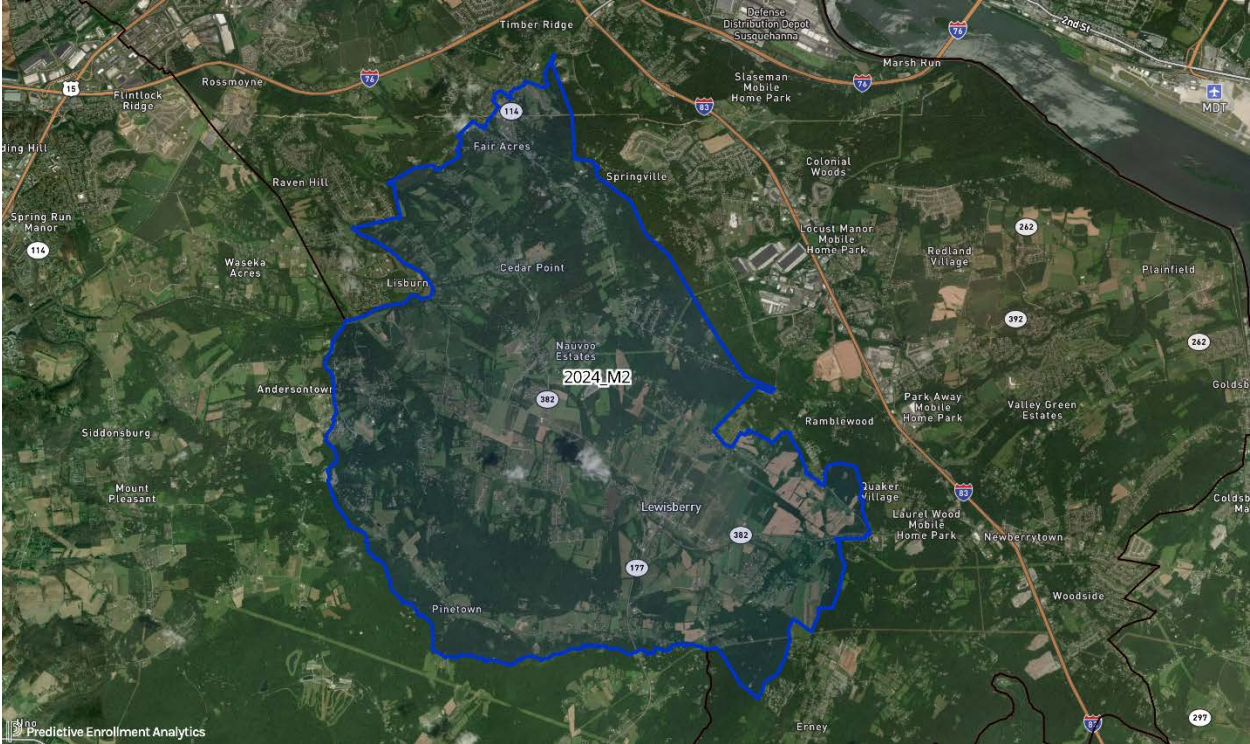
Proposed Change M1 – Timber Ridge



This is currently part of the Fairview/Allen/Cedar Cliff attendance area. The administration recommends shifting to the Hillside/New Cumberland attendance area effective in the 2024-2025 school year.

This change aligns with the recommended change to the elementary attendance areas **E2b** and prevents the creation of a Hillside/Allen attendance area that would separate Hillside students from the rest of their peers who attend New Cumberland.

Proposed Change M2 – AMS/Red Land



This is currently the Allen/Red Land attendance area. The administration recommends shifting to the Crossroads/Red Land attendance area effective in the 2024-2025 school year. This will align the Old Trail Intermediate School, Crossroads Middle School, and Red Land High School attendance areas.
