# Report on the progress made in attaining the goals of the wellness policy (REQUIRED):

The Physical Activity and Nutrition Advisory Council (PANAC) found at least minimal compliance with all but one of the assessment questions at the district level. Work needs to be done to make sure all staff are aware of and educated on the components of the student school wellness policy. The affirmative response to the question on behavioral economics was only possible after receiving clarification from PDE as to what was meant by behavioral economics.
