The minutes of the meeting held February 18, 2016, were approved.

## **Treasurer's Report**

The Board approved the Treasurer's Report for the month ending February 29, 2016, showing invested and available funds of \$37,648,379.61.

### Communications

Mr. Justin Bruhn, Cumberland Perry Area Vocational Technical School (CPAVTS) Administrative Director, thanked the Board and District for their support and introduced two Cedar Cliff High School Seniors who attend CPAVTS to share their experiences.

Catelynne Cutting, cosmetology student, and Pauline Matthew, criminal justice student, described the opportunities that attending a vocational school afforded them and shared their plans for the future following graduation.

Dr. Stoltz distributed a copy of the latest legal update from the solicitor's office and Dr. Argot shared the Central Treasury Reports for Cedar Cliff and Red Land High Schools.

The Board approved the student discipline recommendations as presented.

Dr. Falvo reported that Harrisburg Area Community College (HACC) is renovating the student union and is increasing their scholarship funds. He passed on that there are several scholarships currently available and reminded residents that they can attend HACC at a disccounted rate. In May, HACC will begin negotiating contracts with its sponsoring school districts including West Shore.

Mrs. Crocenzi shared information from the Capital Area Intermediate Unit Board meeting including accolades for Mrs. Stuck, state budgetary concerns, and the anticipated arrival of ballots for the PSERS Board. She also highlighted the Cedar Cliff vs. Red Land Brain Busters competition, Future Chefs Competition sponsored by Sodexo, and thanked the staff at Newberry Elementary School for placing handicap parking signs at the school.

Mrs. Tierney shared exciting news from Red Land High School's Board visit including the work of the students during mini-THON and the success of the musical *Footloose.* She also shared that good work is being done with senior projects; the Science, Technology, Engineering and Math (STEM) initiatives; and a ninth grade PSAT pilot program.

Mrs. Tierney also attended the Crossroads Middle School Board visit where she learned about the formation of a new Parent Teacher Organization, a student lock-in for seventh grade girls, fundraising for Hope Express, and the lasting impact of Sea Camp. Lastly, Mrs. Tierney encouraged everyone to mark their calendars and plan to attend the West Shore Foundation's Gala on October 15, 2016.

Mr. Guistwhite encouraged community members to attend the Board Finance Committee meetings held on the second Thursday of the month at 5 p.m. and the Board Policy Committee meetings on the third Thursday of the month at 5 p.m. He highlighted the work being done by both committees including updates to older policies and new policy formatting.

Mrs. Moyer added her support to Mrs. Tierney's comments about the great things going on at



Red Land High School. She also highlighted the opportunity for Board members to visit CPAVTS on May 10.

Mr. Candioto highlighted multiple successes at CPAVTS, including the popularity of its Café for breakfast on Fridays and Chef McGrath's recent recognition as American Culinary Federation Harrisburg Chapter 181's Chef Educator of the Year. He also mentioned the District's support of CPAVTS students by providing transportation on days West Shore is closed, but CPAVTS is open.

Finally, Mr. Candioto recommended a YouTube video shared by CPAVTS titled <u>Success in the New</u> <u>Economy</u> and encouraged parents to take a few minutes to view the video as they begin to plan for their student's future.

### **Recognition by the Board**

The Board recognized seniors Marie Jendrysik, Cedar Cliff High School, and Eugene Henninger-Voss, Red Land High School, for earning the distinction of National Merit Finalists.

Dr. Argot highlighted the Board room art display featuring students from throughout the District. He also recognized student artists and their teachers who participated in the District's annual Youth Art Month Billboard Project.

Dr. Argot expressed his thanks to Lamar Advertising and the multiple business partners who sponsored the project. A <u>video showcasing</u> the billboards was shared with the Board and each student featured was then presented with a Certificate of Achievement.

Grant Moore, Senior, shared recent events from Red Land High School and Danielle Sklar, Senior, shared recent events from Cedar Cliff High School.



Mrs. Moyer gave shout-outs to Catelynne Cutting, Cedar Cliff and CPAVTS senior who spoke earlier during the meeting, on her accomplishments and shared how impressed she was with the level of performance by students in both high school musicals.

Mrs. Tierney gave a shout-out to CPAVTS staff and students for their assistance in printing the program for Cedar Cliff's musical and she commended them on the quality of the finished pieces.

### Appointment of Bond Counsel


