The Board approved all personnel items as presented.

Recommendation of Feasibility Study Option 1

In the fall of 2016, the [Feasibility and Facilities Committee](#) in conjunction with RLPS, began developing and refining options to address District needs and support instructional programs. Over the course of several months, the committee and Board slowly reduced the number of options until two were under consideration. Multiple opportunities for community feedback in the forms of surveys and presentations, including a town hall meeting on April 24, 2017, were made available, and the input of all stakeholders was taken into account. Based on the recommendation of the Feasibility Committee and District administration, the Board unanimously adopted Option 1, the Feeder School Concept.

During the meeting Mr. Candioto was joined by other Board members in thanking the community for its involvement at public meetings and input throughout the process.

Architectural & Engineering Design Agreement

The Board approved an agreement with RLPS, LLP for Architectural & Engineering Design Services, for projects in Phases 1 & 2 of the approved District-Wide Feasibility Study.

Parameters Resolution

The Board approved a parameters resolution authorizing the issuance of general obligation bonds. This resolution does not obligate the District to incur any debt, rather it establishes the conditions under which the District may opt to incur debt at a future date for the purpose of completing the projects contained within the approved District-Wide Feasibility Study.

Disposal of Unused Items

The Board approved the sale/disposal of obsolete equipment or items no longer needed through the services of PublicSurplus.com.

Chesapeake Bay Trip

The Board approved a field trip for New Cumberland Middle School students to visit the Karen Noonan Center in Dorchester County, Maryland, from May 10-12, 2017, in order to study the ecology of the bay and its tributaries.

Appointment of Solicitor/Labor Counsel

The Board reappointed Stock and Leader, LLP, as Solicitor/Labor Counsel.

Election of Board Secretary & Treasurer

The Board reelected Dr. Argot as Secretary and Mrs. Stuck as Treasurer.

The Board authorized execution of a settlement agreement as recommended by counsel for the District.

Contract for Athletic Trainer Services

The Board approved the renewal of a contract for three years with Central PA Rehabilitation Services, Inc.

Cooperative Sponsorship Agreement

The Board approved a Cooperative Sponsorship of a sport (swimming/diving) between the District and the West Shore Christian Academy. Pending District III and PIAA approval, this cooperative sponsorship would go into effect for the 2017-2018 school year and extend for two years.

Adoption of Online Learning Provider

After researching online learning providers, the

District approved the Capital Area Online Learning Association (CAOLA) as an online service provider.

Learning Management System Implementation

Schoology is a learning management system (LMS) which provides an online resource for teachers to build classroom content and instruction. A small group of teachers from Red Land High School, Crossroads Middle School, and Red Mill Elementary School have been selected to be part of a three-year personalized learning pilot. The Board approved Schoology be used as the LMS for this pilot.

Staff Attendance at Professional Meetings

The Board approved staff attendance at professional meetings as presented.

Management Services Agreement

The Board approved the Management Services Agreement between the District and Aramark Management Services Limited Partnership, beginning June 10, 2017, for an initial term of approximately five years through June 30, 2022.
